CUSTOM ORDERS*

When ordering custom items, be sure to neatly and accurately print all information requested in section 8 of the order form. We cannot produce these items unless this information is provided, and we cannot be responsible for your errors.

PLEASE NOTE: Custom items require approximately three days to produce (Business Cards approximately 2-4 weeks).

Custom items will be shipped separately as soon as they are available.

***CUSTOM ORDERS:** includes Notary Seals, Library Embossers, Stationery Embossers, Custom Stamps, Mini Address Stamps, magnets, rolodex cards, and Business Cards.

NOTARY SEAL AND EMBOSSER SHIPPING

Notary Seals are custom made to your state's specifications. Allow 2-3 business days to produce. Seals will be withheld until all required documents are received. If required documentation is not submitted at the time of order, you may receive two separate shipments.

NOTE: If your order cannot be completed within one year (365 days) after the NNA has received it due to your failure to notify us of your commission commencement date, your payment will be non-refundable.

REQUIREMENTS FOR NOTARY SEAL STAMPS

IMPORTANT: The following documents are required to provide your Official Notary Seal Stamp. Please mail or fax the required documents to the NNA.

CA, ND and OR: Mail your ORIGINAL "Certificate of Authorization" (not a copy).

FL: If ordering a Notary Seal, please send a COPY of your Notary "Commission Certificate." For NNA Complete Notary Supply Package, no documents are required.

Guam: Send a COPY of your "Commission Certificate" AND mail your ORIGINAL, notarized "Application for Seal."

HI: Send a COPY of your "Letter of Passing."

ID, KS, NM, SD and WI: Order your seal, then forward a COPY of your "Commission Certificate" within 30 days.

NV: Mail your ORIGINAL "Certificate of Appointment" or original CERTIFIED copy.

PA: Send a COPY of your "Commission Certificate" or "Appointment Letter" AND provide your city, township or borough and county of business.

TX: Available in Elite, Value and Slim Stamp Notary Seals only. Send a COPY of your Notary "Commission Certificate." State employees without a Notary Bond must note the following on their request when ordering seals: "NOTARY WITHOUT BOND."

UT: Send COPY of your notarized "Commission Certificate."

AL, DC and VI: Notary Seal Stamps not permitted by state/district; please select a Notary Seal Embosser.

All Other States: Send a COPY of your Notary "Commission Certificate" or "Letter of Appointment."

REQUIREMENTS FOR NOTARY SEAL EMBOSSERS

IMPORTANT: The following documents are required to provide your Official Notary Seal Embosser. Please mail or fax the required documents to the NNA.

CA and ND: Mail your ORIGINAL "Certificate of Authorization" (not a copy).

Guam: Send a COPY of your "Commission Certificate" AND mail your ORIGINAL, notarized "Application for Seal."

ID, KS, NM, SD and WI: Order your seal, then forward a COPY of your "Commission Certificate" within 30 days.

OR: Send a COPY of your "Commission Certificate."
PA: Send a COPY of your "Commission Certificate" or "Appointment Letter" AND provide your city, township or borough and county of business.

HI: Send a COPY of your "Letter of Passing."

NV: Mail your ORIGINAL "Certificate of Appointment" or the original CERTIFIED copy. No faxes accepted.

UT: Send COPY of your notarized "Commission Certificate."

VI: Send COPY of your "Commission Certificate" with name of District. (Specify if government employee.)

All Other States: Send a COPY of your Notary "Commission Certificate" or "Letter of Appointment."
