

Deed Fraud


• Fraudulent conveyance or transfer of title or an interest in real property.








Top Metropolitan Statistical Areas






Top 10 Zip Codes for Mortgage Fraud






Occupancy Fraud Risk MSAs






Identity Theft Fraud Risk MSAs






Red Flags: Misrepresentation






Red Flags: Powers of Attorney






Red Flags: Documentation






